When confronted with the need and requirement for service to the university and the community, it is easy to be overwhelmed by the many opportunities. I have chosen to focus my attention on roles that serve my department and the university. In general, the activities also further my goals in other criteria for professional evaluation.

The collection of artifacts has given me a new sense of my role in serving the broader community. In a sense, I try to get double- or triple-duty from any activities in which I am involved. For example, my assignment as acting director of the Center for Excellence in

Teaching and Learning. I learned a lot in that role that will improve my teaching methods. Another example is my service on the College of Education's International Studies Committee and as a member of the Global Guidelines Task Force for the Association for Childhood Education International. Those roles further my efforts of international partnership for teaching and research. Participating in the College's Hooding Ceremony and in MSU's Commencement Ceremony also involves service to students.

Service to the EEC Department

I have been a member of the EEC department since Fall, 2005. My first position was as a fixed-term faculty member. In Fall 2006, I was hired for a tenure-track position.

As a member of the EEC department, I was a member of the EEC Early Childhood Assessment Committee, AY06 and AY07. I was the lead writer for the department assessment report (see PDR AY07). That is why there is the practice of review and approval. If department members see errors or omissions, it is their responsibility to bring up those mistakes and seek corrections before they approve the minutes as a department.
