#### **Course Description and Objectives:**

The purpose of CMST 333 is to cultivate and refine your mastery of presentational skills through speech construction, delivery, and analysis. You should consider this course an advanced skills-based class. Although we will spend a short amount of time reviewing introductory public speaking skills, it is assumed you have some experience with public speaking. As such, this course will build on your existing knowledge and skills to help you master oral and written communication practices. This course will focus almost exclusively on practicing public communication skills through the development, delivery and critique of a variety of public speaking assignments.

Your successful completion of this course will fulfill the following learning objectives:

- 1. Identify personal weaknesses in oral and written communication;
- 2. Develop strategies to improve oral and written communication weaknesses;
- 3. Recognize effective oral and written communication practices in diverse contexts;
- 4. Interpret and explain complex or technical information;
- 5. Demonstrate effective oral and written communication practices in diverse contexts;
- 6. Analyze oral presentations for their strengths and weaknesses.

## **Attendance Policy:**

CMST 333 is a performance-based class: you learn and master the course material by actively putting it into practice. As such, regular attendance and participation is required. I will take attendance every day and keep track of your meaningful participation in class discussions. You have the opportunity to miss two (2) class sessions without question. Missing more than two sessions will result in your final semester grade being lowered by 5% (the equivalent of ½ letter grade) for each absence beyond 2. Absences are *excused* if they are for *documented university-sponsored travel* or *dire personal emergencies*. As a final note: I am not responsible for "catching you up" if you miss class—it is your responsibility to stay current in your work. Please use your classmates as resources to assist you.

#### **Work Policies:**

Any late work will be subjected to an automatic 50% grade deduction. I will not accept ANY late work a week after the due date. You should also note that, because of the constraints of meeting only once per week, there is no guarantee you will be able to make up oral presentations if you miss your assigned date.

I also have stylistic expectations for all written work in this class. Any written work, unless specified otherwise, should comply with the following expectations:

- All work submitted electronically MUST be in a Word document, or a format I can open with Microsoft Word:
- Type your work and double-space everything;
- Use a serif font (either Times New Roman or Cambria);
- Margins should be 1" all around;
- Assignments more than one page should be stapled together;
- Assignments more than two pages should include a cover page with your name and the course number;
- Anything written by someone else and used in your assignment should be cited in-text and included in a reference section according to the American Psychological Association (APA) style guide, 6<sup>th</sup> edition.

If the above requirements are not met, I will return the work to you—ungraded—and you will have the opportunity to make corrections, subjected to the late work penalty.
